

PRIVACY NOTICE

Effective date: 7 April 2026

The purpose of this Privacy Notice is to set out the data protection and data processing principles applied by Fodor Humán Szolgáltató Bt. (hereinafter: the "Controller") and to provide information to visitors of the website and persons completing the contact form about the processing of personal data pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council (General Data Protection Regulation – GDPR) and Act CXII of 2011 (the Hungarian Information Self-Determination and Freedom of Information Act – Infotv.).

1. Details of the Controller

2. Categories of personal data processed

The following data must be provided through the contact form available on the website:

- Name
- Telephone number
- Email address

The Controller does not automatically collect any other personal data through the contact form.

3. Purpose of processing

The purposes of processing are:

- Enabling contact to be established
- Responding to the data subject's enquiry
- Providing information concerning the subject of the enquiry
- Initiating subsequent communication at the request of the data subject
- Consulting and coordinating in connection with services

The Controller processes the data exclusively for contact and communication purposes.

4. Legal basis for processing

The legal basis for processing is the data subject's voluntary and explicit consent pursuant to Article 6(1)(a) of the GDPR.

The data subject gives consent by completing the contact form and accepting this Privacy Notice. The provision of data is voluntary; however, contact cannot be established without it.

5. Retention period

The Controller stores the personal data provided:

- For 12 months from the date of the last contact; or
- Until the data subject requests their deletion.

Unless retention is required by law, the data will then be permanently deleted.

6. Persons authorised to access the data

Personal data may be accessed exclusively by the Controller and persons commissioned by the Controller who participate in performing the relevant work.

The Controller does not sell, rent out or transfer the data to third parties for marketing purposes.

7. Data processors

For the storage and processing of data, the Controller uses the following data processor:

The processor processes the data solely for the performance of technical tasks and does not use it for its own purposes.

8. Data security

The Controller takes appropriate technical and organisational measures to ensure that personal data is protected against unauthorised access, is not disclosed to the public, is not damaged and is not destroyed.

Data processing takes place on a password-protected system using SSL encryption.

9. Rights of the data subject

The data subject has the right to:

- Request information about the processing of their personal data
- Request the rectification of their data
- Request the erasure of their data (the “right to be forgotten”)
- Request restriction of processing
- Request data portability

The Controller will examine the request and provide a substantive response no later than within 30 days.

10. Remedies

If the data subject believes that their rights have been infringed, they may lodge a complaint with the following supervisory authority:
